# Narcisa Przulj

SHAREHOLDER IN ST. LOUIS, MO

Having exclusively practiced employment law since 2007, Narcisa Przulj is a shareholder of the firm and member of the Business Litigation and Business Law practice groups. Originally from Sarajevo, Bosnia & Herzegovina, Narcisa moved to St. Louis as a refugee at the age of 14.

She focuses on employment and non-compete litigation and counseling. As an experienced litigator and trial attorney, Narcisa defends employment-related claims, including discrimination, harassment and retaliation claims, as well as breach of contract, misclassification, and failure to pay overtime claims. She responds to charges brought before administrative agencies including the EEOC, NLRB, MCHR and IHRC. She also handles DOL and other federal, as well as state agency audits.

Narcisa also assists businesses and individuals with employment, severance and non-compete agreements. Because of her extensive litigation experience, Narcisa understands how a jury may react to various internal policies and procedures, allowing her to offer practical, cost-saving advice when acting as general counsel on employment related matters for her clients. As a counselor, Narcisa advises her clients on issues ranging from every-day human resources matters involving ADA accommodations and FMLA leave, to public accommodation concerns, and investigations of sexual harassment complaints and workplace violence threats.

#### REPRESENTATIVE EXPERIENCE

Following a week-long jury trial in St. Louis County Circuit Court, Narcisa obtained a complete defense verdict on behalf of an employer and two individual defendants. The lawsuit alleged race and sex discrimination and retaliation under the Missouri Human Rights Act. Only 21 of the original 75 claims brought by the Plaintiff were submitted to the jury after dismissal of the other 54 claims through motions for summary judgment and directed verdicts.

Complete defense verdict in a breach of contract case trial in St. Louis County.

After obtaining partial summary judgment, Narcisa negotiated a favorable settlement in a breach of contract, failure to pay commissions, natural origin discrimination and unjust enrichment lawsuit under the Missouri Human Rights Act and Missouri common law.

Representing a client in a non-compete matter, Narcisa obtained a permanent injunction against a former employee and their new employer, enforcing both the non-compete and non-solicitation provisions of the employment agreement.

Narcisa achieved a summary judgment in the United States District Court for the Eastern District of Missouri on claims of race and age discrimination in termination, denial of promotion, harassment and retaliation under federal and Missouri state law.

Narcisa won summary judgment in a pending case involving racial discrimination in the United States District Court for the Southern District of Illinois.

Narcisa obtained a summary judgment on claims of sex and age discrimination, including the denial of promotion and training, denial of equal pay, retaliation, breach of contract and promissory estoppel under Title VII, the ADEA, the EPA, the KAAD and Kansas state law in the United States District Court for the District of Kansas.

Also in the United States District Court for the District of Kansas, Narcisa won a summary judgment on claims of disability discrimination, failure to accommodate, retaliation and workers' compensation retaliation brought under federal law and Kansas state law.
